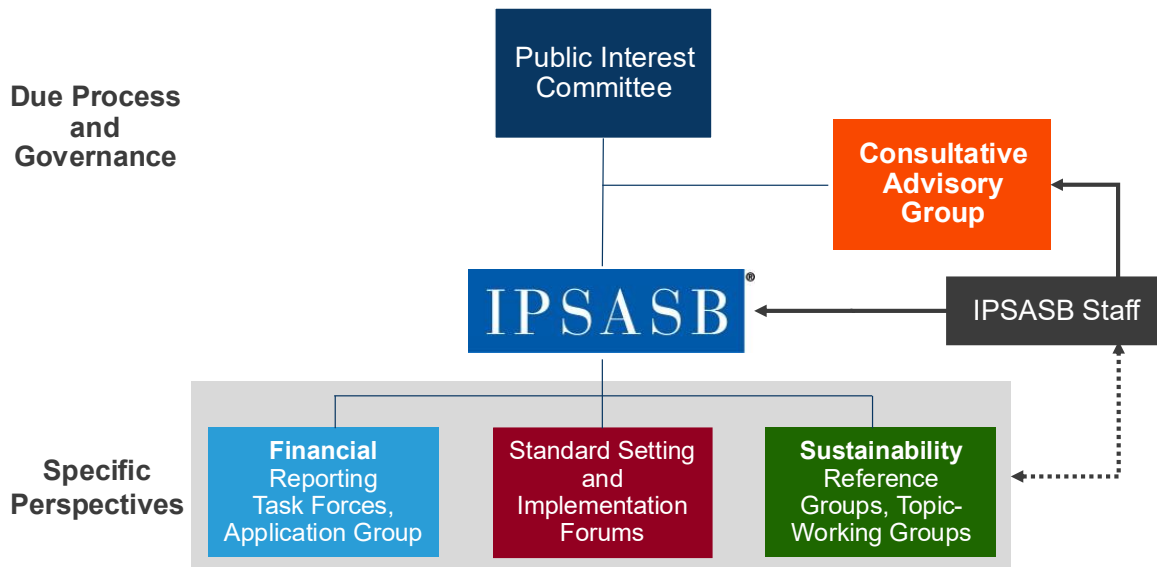

Strategic Evolution of the IPSASB

Session Background

1. The IPSASB Consultative Advisory Group (CAG) plays an integral role in the due process and governance of the IPSASB. Engagement with the CAG is a critical part of the IPSASB's formal process of consultation, as CAG members' advice on strategic, technical, implementation, and other relevant matters supports the IPSASB in achieving its Strategic Objective. By fulfilling its vital role in the IPSASB's due process and standards development process, the CAG has added significant value to the IPSASB since its inception in June 2016.



2. There have been two major developments since the beginning of 2026:
 - (a) Thomas Müller-Marqués Berger began his term as Chair of the IPSASB; and
 - (b) The IPSASB introduced several new implementation initiatives, in direct response to constituent feedback and in connection with the direction and focus under the new Chair's leadership.
3. Naturally, these developments are evolving the IPSASB at a strategic level in 2026 and beyond. The IPSASB Chair and Staff would like to share a comprehensive update with CAG members regarding these developments to gather members' advice on potential next steps.

Request for CAG Members

4. This session is intended to:
 - (a) Provide CAG members with a deeper understanding of the new activities supporting implementation and how they impact the strategic evolution of the IPSASB to keep pace with evolving public sector needs;
 - (b) Gather advice from CAG members on what the IPSASB should consider as it develops its next Strategy, and as it engages stakeholders on its future Strategy consultation; and
 - (c) Gather advice from CAG members on how the IPSASB can clearly and effectively communicate its evolution to its stakeholders.
